Obtain relevant background documents from the client.


Identify key preliminary issues, provide comments on the Terms of Reference (TORs), and establish legislative provisions or constraints.

Render a final opinion that may lead to further transactional or litigation instructions from the client.

Prepare an Inception Report to detail the client's objectives and a timetable outlining necessary steps.



2 Litigation & Alternative Dispute Resolution:

In situations that call for litigation or alternative dispute resolution, we employ a strategic, meticulous approach to guide our clients through each step. Our methodology involves:

Obtaining instructions and background documentation from the client.

Reviewing the client's instructions and documents and providing an initial opinion on the intended suit.

Meeting and interracting with the client to understand facts of the case.

Serving a notice of intended suit to the other party unless urgency or strategic reasons suggest otherwise.

Preparing court papers and reviewing them with the client.

Filing the suit in court or submitting it for arbitration.

Registration and execution of Arbitral awards within the necessary jurisdiction.

Preparing and filing any necessary interlocutory relief papers, and pursuing the hearing of applications.

Following applicable arbitration procedures to obtain hearing dates and manage any arising matters.

Vigorously following up on the matter to secure hearing dates, encourage settlement, and advise the client on the best way forward in the face of potential court delays.

Upon obtaining a judgement, extracting a decree, updating the client, and advising on execution for the collection of judgement/decree fruits or enforcement of arbitral awards.

In defence cases, discussing the merits and demerits of the case with the client and seeking alternative dispute resolution mechanisms where possible.



Transactional Work:
